ANNOUNCEMENTS

Mr. Hickmann gave an update on the District's response to the COVID-19 pandemic, announced the rate virtual forum on August 25, provided further information on the July 16 water quality virtual summit and distributed an updated Board Communications Log (see attached memo).

In response to Board feedback, Mr. Hickmann said he will reach out to Senator Merkley to provide feedback on potential federal legislation that may prohibit water shutoffs following use of federal CARES Act funding.

Mr. Kraska gave the safety moment on working safely around bees and wasps.

1. DISCUSSION ITEMS

A. Willamette Water Supply System Commission Update. Staff Report – Dave Kraska

Mr. Kraska described the August Willamette Water Supply System Commission Board meeting agenda, reviewed the latest details from the Approvals and Procurement Forecast and updated the Board on recent Willamette Water Supply Program activities of note (see attached presentation).

B. Future Portland Regional Water Sales Agreement. Staff Report – Paul Matthews

Mr. Matthews highlighted the key concerns surrounding the District's notice of termination of the agreement, discussed regional water issues, outlined the District's goals for a future agreement and described the consultant-led approach, jointly developed principles and concepts the participating utilities are discussing (see attached presentation).

In response to Commissioner feedback and to provide greater context, staff said:

- Portland staff's potential interest in moving from using an agency's budget to some measure of actual operations and maintenance costs in future agreement pricing is likely based on a desire for simplicity.
- The Willamette Water Supply System (WWSS) will be a regional, resilient water source and is structured so that those who benefit from the system also contribute to the cost of it.
- In the 1970s, Metzger Water District constructed a pipe to convey water from Portland into the Metzger area and the Washington Square shopping center. The pipe included interconnections for the cities of Tigard and Beaverton. The line was jointly funded by Metzger Water District, the developers of the Washington Square shopping center and the cities of Tigard and Beaverton. After construction, the pipe was donated to the City of Portland. When the City of Tigard no longer accessed water from the pipe, there were water quality concerns related to reduced flow. TVWD staff is working on an agreement that would provide District ownership of the line to repurpose it for use within the District's distribution system and wheel water to City of Portland water customers along the pipeline route. The line would be available to provide WWSS water to the Metzger area. It would also provide the cities of Tigard and Beaverton with an interconnection point to the WWSS system and emergency water supplies. Staff from each agency has been working cooperatively to utilize the asset to regional benefit.
- The agencies participating in the discussion of a new regional agreement recognize the Washington County Supply Line was not built to the lateral force resistance standards that would enable the line to withstand a significant subduction zone earthquake.

I will cover the following items during the CEO's Announcements at the work session:

- 1. **Be Sure to Use Microphones** Just a reminder to please be sure to use your microphone whenever you are speaking during the work session this evening. Also, please be sure to turn off your microphone when you are not speaking.
- 2. COVID-19 Update Tualatin Valley Water District (TVWD) continues to navigate and respond to challenges posed by the current pandemic. The Emergency Operations Center (EOC) remains committed to providing structure, educating staff and coordinating response efforts. I am pleased to announce that TVWD has been awarded \$236,715 in grant proceeds as part of the CARES Act funding from Washington County. These funds will reimburse the District for some of its COVID-19 response expenses. A huge thanks to our Finance team for pulling the information together so we could get this money to help offset our costs.
- 3. Rate Virtual Forum TVWD will be hosting a rate virtual forum, Tuesday, August 25, from 12:00-1:30 p.m., to discuss the upcoming rate increase. A presentation will be followed by a question-and-answer session. The Board and public are encouraged to participate. Registration information will be available on TVWD's website in the near future.
- 4. Water Quality Virtual Summit Update The Water Quality Virtual Summit was held Thursday, July 16. Fifty people participated in this event using Microsoft Teams, exceeding our goal of 20 participants. As of July 30, 17 participants responded to the post-event survey expressing high satisfaction with the entire event and the format. Future event topics were tested with the top five being: Willamette Water Supply Program (14 votes), Water Distribution: Source to Tap (11 votes) and with nine votes each for Source Water Protection, Emergency Preparation/System Resilience and Emerging Technology in Water Industry. This event was made possible by collaboration with Joel Cary, Water Resources Division Manager, and Tim Boylan, IT Services Director.

- 5. **Board Communications Log** There were two updates to the Board communications log this month. Topics included enforcement orders on wildlife habitat protection pertinent to Willamette Water Supply System projects and microplastics. Please see the attached for details.

Tom,

Thanks for forwarding on Commissioner Doan's question about the May 22nd Oregon Land Conservation and Development Commission vote to issue an enforcement order (including an injunction) on Washington County regarding wildlife habitat protection.

WWSP staff have reviewed the final order and interpret that the order applies only to applications that include residential housing development. Since WWSP applications do not include housing, our applications can continue to be approved by the County.

We have successfully verified this interpretation with the County's senior planning staff. WWSP staff will monitor the related County updates to the Significant Natural Resource Areas code to identify changes that could affect non-residential development in the future.

Tom,

Is this going slow the WWSS down?

In it's meeting on Friday, May 22, 2020, Oregon Land Conservation and Development Commission voted 6-0 to adopt the Hearings Officer recommendation to issue an enforcement order. The Commission also went a step further and voted to impose an injunction on the County, prohibiting it from processing applications for developments in designated "Wildlife Habitat" until it came into compliance with state law by adopting new and enforceable regulations. The Enforcement Order was issued on June 2, 2020. Under the Commission's order, the County has until May 1, 2021 to come into compliance. In the meantime, Ms. Warren and others who have been actively involved in legal

challenges to the development of SNRs in Washington County hope to work with the County in crafting the new ordinances to ensure that what remains of these sensitive Wildlife Habitat areas will be given meaningful protections.

Hi Commissioner Doane,

There are currently no federal regulations for microplastics in drinking water or waste water effluent.

The closest is California, which began the process in 2018. The first step was defining what constitutes a microplastic particle. Sounds kind of dull but it's actually really fascinating – and a little alarming – given the scope of plastic particulate found in the environment (e.g., more particles can be found at the immediate surface of a water body when collecting samples). This was just completed June 3. Finally, by July 1, 2021, California must adopt test methodology for microplastics in drinking water, adopt requirements for four years of testing and reporting on microplastics in drinking water, and develop accreditation requirements for laboratories to analyze microplastics.

I mention all this because California often leads the way for federal action, so this might give us a rough sense of an overall regulatory timeline depending on what widespread testing reveals. I have not heard of any consideration by Oregon to do the same.
