Subject: Review of District Infrastructure

Key Concepts:

• The District owns and operates a water infrastructure system that delivers clean, safe, and reliable drinking water to a population of nearly 230,000.

- The Engineering and Operations Department is responsible for planning, designing, constructing, operating, and maintaining District infrastructure.
- This informational presentation will provide an overview of existing District infrastructure.

Background:

As the second largest drinking water provider in the state of Oregon, TVWD delivers an annual average of approximately 21 million gallons of water every day to homes and businesses. This is accomplished through a complex network of valuable infrastructure which includes 23 active reservoirs, 12 pump stations, an aquifer storage and recovery well (ASR well) capable of storing more than 300 million gallons annually, 5,313 fire hydrants, 22,295 valves, 752 miles of water mains, and numerous other assets related to the delivery of safe, reliable drinking water every day.

In the 2018 Master Plan Update, in addition to capacity improvements, staff identified the need for over \$300 million in future spending needed to maintain and replace piping as part of the Mains Replacement Program. The water mains in the District are aging and experience external corrosion from a variety of challenging environmental conditions. Staff also recognize that other infrastructure assets continue to age and are subject to some of these same environmental conditions, which also require a comprehensive maintenance and replacement program.

This brief presentation will provide an overview of the existing conditions of District infrastructure and asset management strategies which are proposed to properly maintain the water system for the long-term benefits of District customers.

Budget Impact:

There is no direct budget impact associated with this informational presentation. Any identified capital improvement needs will be presented during the District budget approval process.
